- 7. There is no financial commitment on the part of the name of institution, if there is any financial consideration, it will be dealt with proper process.

This MoU/agreement will be effective for five years from the date of signing by the authorized signatories of each party.

Any party may terminate this MoU and any related agreement for any reason by giving 30 days prior written notice to the other party.




